General Statute 115C-307 states “it shall be the duty of all individuals given authority over some part of the school program to maintain good order and discipline.” In addressing inappropriate behaviors, each school has defined consequences for inappropriate behaviors. In compliance with Board Policy 4.3610, one of the consequences is corporal punishment. However, corporal punishment is used as a least resort for cumulative misbehavior where other strategies have not been effective or when the offense is of a serious nature such as fighting, vandalism, and/or gross disrespect.

Board of Education Policy 4.3610 states the use of corporal punishment as a consequence for inappropriate behavior shall be a collaborative decision between the school and the parents, or guardians of each student...parents and/or legal guardians shall be asked to respond in writing indicating their approval or disapproval of corporal punishment in a disciplinary issue involving their child. Therefore, we are requesting your response to the statements listed below.

The policy states that an alternative(s) to the use of corporal punishment shall be identified if a parent/guardian opposes the use of corporal punishment.

- Saturday detention
- In-school discipline in compliance with Board of Education Policy

Yog li ntawd, peb thov koj teb cov lus hauv qab no saib koj pom zoo licas.

Tsis tag li, txojcai tseem hais ntxiv tias yog niamtxiv lossis tus saib xyuas menyuam tsis pom zoo siv kev qhuabqhia uas yog nplawm pob tw no, yuav tsum tau nrhiav lwm txojkev los qhuab qhia menyuam kom coj tus yamntxwv/cwjpwv zoo nyob hauv tsev kawmntawv.

Lwm txojkev siv los qhuabqhia es tsis yog nplawm pob tw (corporal punishment) muaj raws li ntawm no:

- Muab kham tseg tsis pub kawmntawv muab rau txim hauv tsev kawm lossis tom tsev (suspension)
- Rau txim ua ntej lossis tom qab thaum lub sijhawm kawmntawv (before/after school detention)
- Raug txim tau tuaj kawmntawv hauv tsev kawm hnub Vasxaum (Saturday detention)
- Tsev kawmntawv yuav qhuabqhia raws li txojcai tsavxwm tau teev tseg
